 - Sibling of a programmed project
 - The project has a NEPA document completed within the last 10 years or the NEPA document was actively being worked on
- Project Submittals for MPOs and RPOs:
 - Base of 12 submittals, plus:
 - One additional submittal for every 50,000 in population
 - o One additional submittal for every 500 centerline miles
- Divisions:
 - o 14 submittals each
- Applies to each mode
- 3. Election of Officers Tyler discussed election of officers:
 - Tyler made a motion to nominate the following officers for 2017

 - Tyler M. Vice-Chair
 - Hank G. Treasurer

 - Bob Cook seconded the motion which passed unanimously
- 4. PL and STP-DA Planning Agreement Discussion Peggy Holland and Jamal Alavi discussed planning agreements:
 - Peggy and Jamal have been working on language/adjustments for the planning agreements
 - When the documents are updated a draft will be sent out the MPOs
 - Chris and Mike both want the agreements signed by the MPO and LPA
- 5. PL Balances and PL Formulas Paul Black led a discussion on MPO PL balances and funding:
 - Some MPOs are consistently unsuccessful taking down the money they are allocated
 - Some Possibilities:
 - Not enough eligible work in a given MPO
 - Unable to secure full local 20% match funds
 - Purposely accruing for large expenditure

- Want to avoid funds going to a rescission
- Look at providing some relief for MPOs that are underfunded for the work they are doing
- Proposal to allow MPOs to carry 150% of PL funding anything over that could be redistributed among other MPOs
- MPO funds can be protected if the MPO identifies what the additional funding is going to be used for
- Bob League wanted to enforce the 3 year obligation first
- Jennifer Collins wanted to know how the additional funds would be redistributed
- Redistribution of funds will be decided later
- Tyler Meyer made a motion to approve the 150% PL funding balance proposal. Suraiya seconded the motion
